28. The Board of trustees may borrow funds for accomplishing the objects of the trust.
29. Every power, authority or discretion conferred on the trustees shall be exercised or signified either by an instrument in writing to be signed by all the trustees or such of them as may be present or by the resolutions of the Trustees or such of them as may be present there and vote at any meeting of Trustees. The quorum for the purpose of such meeting shall be the presence of two persons. No business except for adjourning the meeting to a particular date shall be transacted at any meeting of the Trustees unless there shall be a quorum.
30. In case of difference of opinion arising amongst the Trustees and in all matters wherein the Trustees shall have a discretionary power, the opinion of the majority of the Trustees present and voting shall prevail and be binding on the majority as well as on those Trustees who may not have voted and if the Trustees shall be equally divided the matter shall be decided according to the casting vote of the Managing Trustee.
